SUBJECT: Hawaii State Assessment-Alternate Test Administrator Training

The Assessment Section, in the Office of Strategy, Innovation and Performance, will provide inperson training for Hawaii State Assessment-Alternate (HSA-Alt) Test Administrators in January 2023. All new HSA-Alt Test Administrators are required to attend this one-day in-person training, and it is highly recommended for returning HSA-Alt Test Administrators to attend the training. Special Education Department Heads, Student Service Coordinators, and district and complex area staff are also invited to attend the HSA-Alt Test Administrator Training based on space availability.

What to Bring

Each participant should bring one student device such as an iPad, Chromebook, or other device used by the student during test administration of the HSA-Alt, and one computer as a test administrator device. Both devices should be fully charged.

All devices should be updated to a supported version of the operating system on the <u>Supported</u>
<u>Browser</u> page on the <u>alohahsap.org</u> website. The current version of the CAI secure browser should be downloaded to the student's device prior to the training. The current year Secure Browser can be downloaded from the <u>Secure Browsers</u> page on the <u>alohahsap.org</u> website.

In addition, please have the 10-digit SSID number(s) and first name(s) of the student(s) who will be participating in the HSA-Alt assessments.
